Ukrainian Part

The Ukrainian-Chinese Business Council (UCBC) was established in September 2010 during the official visit of the President of Ukraine to the People's Republic of China. It was created on the basis of a bilateral agreement between the Ukrainian Chamber of Commerce and Industry and the China Council for the Promotion of International Trade as a permanent platform for business communication between the two countries.

The Council operates in the areas of developing trade and economic relations, attracting investment, fostering industrial cooperation, and promoting cultural and educational exchange between Ukraine and **China — Ukraine's largest trading partner.**

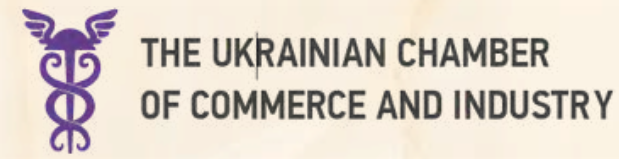


On 16 February 2026, the inaugural meeting of the renewed composition of the Ukrainian side of the UCBC was held, bringing together representatives of 105 companies. **Hennadiy Zubko**, former Vice Prime Minister of Ukraine, who previously chaired the Ukraine–China Intergovernmental Commission on Cooperation, **was elected as Chairman.**

In his remarks, he outlined two key principles guiding the Council's work: **adherence to Ukraine's national interests and economic pragmatism.**

The parties confirmed their shared interest in a significant **increase in trade turnover.** At the same time, Ukraine identified as a priority the development of a balanced trade structure, with expanded presence of Ukrainian companies in the PRC market and an increased share of value-added products in bilateral exports.
